(\*) Paid Time Off (PTO) contribution is paid at time and one-half on all overtime hours.

(\*\*) Dues are included in the base wage for all classifications and for all hours worked. After taxing, deduct the appropriate Dues from wages.

The per employee amount which is included in the "Composite Rate" is sent to the Joint Trust Depository. For Classifications paying (\$1.85) Dues, such dues are comprised of District Council 16 Dues Check-Off (\$1.10), Local Union 230 Dues (\$0.65) and United Association Organizing (\$0.10).

First Year Apprentice Dues of (\$1.35) are comprised of District Council 16 Dues Check-Off (\$1.10), Local Union 230 Dues (\$0.15) and United Association Organizing (\$0.10).

Note: The Employer shall pay to the ARCA/MCA Promotion Fund (\$0.38) per hour worked for all classifications under this Agreement. That amount, which will be included in the "Composite Rate" is to be sent to the Joint Trust Depository.
