(*) Health and Welfare rate includes (\$0.50) per hour as described in Section LA 4.01.D for all Apprentice Classifications.

(**) (\$0.01) of the 401a Defined Contribution shall be used to pay the program administrative costs.

(***) Dues are included in the base wage for all classifications and for all hours worked. After taxing, deduct the appropriate Dues from wages. The per employee amount which is included in the "Composite Rate" is sent to the Joint Trust Depository. For classifications paying (\$2.85) Dues, such dues are comprised of District Council 16 dues check-off of (\$1.10), Local Union 250 Dues (\$0.70), Local Union 250 Retiree Christmas Bonus (\$0.95) and United Association Organizing (\$0.10). For classifications paying (\$2.20) Dues, such dues are comprised of District Council 16 dues check-off of (\$1.10), Local Union 250 Dues (\$0.05), Local Union 250 Christmas Bonus (\$0.95) and United Association Organizing (\$0.10).

(****) Refer to 11.02F for Probationary Period application.

Note: The Employer shall pay to the ARCA/MCA Promotion Fund (\$0.38) per hour worked for all classifications under this Agreement. That amount, which will be included in the "Composite Rate" is to be sent to the Joint Trust Depository.
